PROFIT WARNING

This announcement is made by Loco Hong Kong Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders and potential investors of the Company that, based on a preliminary review of the unaudited financial information of the Group, the Group is expected to record a significant increase in loss for the six months ended 30 June 2017 as compared to the unaudited results of the Group for the corresponding period in 2016. Such increase in loss for the period as compared to the last corresponding period in 2016 were mainly attributable to the increase in employee cost, finance cost (interests on convertible bonds) and loss on disposal of investment held for trading.

This announcement is made solely on the basis of a preliminary assessment made by the management of the Group with reference to information available for the time being, including the unaudited financial information of the Group, which has not been finalized nor reviewed by the Company’s auditor and audit committee. Interim results of the Group for the six months ended 30 June 2017 will be disclosed in the interim result announcement of the Group, which is expected to be published on 14 August 2017.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
